WE ALSO FUNCTION AS THE LIBRARY'S FOUNDATION, MANAGING \$18.5 MILLION IN ENDOWMENT ASSETS. IN 2025, THE FRIENDS SENT \$762,000 TO SUPPORT SAINT PAUL PUBLIC LIBRARY PROGRAMS AND \$342,000 IN CAPITAL GRANTS FOR BUILDING RENOVATIONS. ABOUT 25% OF FRIENDS FUNDING WENT TO SUPPORT LIBRARY PROGRAMS FOR CHILDREN, YOUTH, AND FAMILIES SUCH AS HOMEWORK CENTERS AND THE SUMMER READING PROGRAM. BECAUSE OF THE FRIENDS, THE LIBRARY CAN SPARK THE JOY OF READING FOR KIDS, SUPPORT STUDENTS IN THEIR ACADEMIC JOURNEYS, AND TRANSFORM CHILDREN'S AREAS WITHIN EACH LIBRARY.
